Design Issues - Dan Stewart (engineer unable to attend)

- building to accommodate largest user ATV and horse
- not feasible to build beside the embankment
- when rail comes back the trail needs to move
- bridges wood base, fences
- width 120 inch width some places wider if we reduce the heights
- trail speeds wll be paramount as the trail is only 10' wide slower speeds on corners
- remove ties, grade, add surface about current material
- goal is not to increase cost to reestablish rail
- access points will have a removable bollard to allow emergency vehicle access
- design decisions will be made in the future the details do not need to be worked out here and now

Questions and Answers

- Bridges most are good enough for current trail safety
- Management authority will be responsible for maintaining the bridge until rail returns. This is true even if the bridge is wiped . nee to identify funding?
- Trail Management Committee
- Fencing for abutter protection -will be considered for safety reasons, generally not for abutter protection

- Crossing permits will be the same as they are today. People apply, get a hearing, Thinking long term about the rail in the future
- Spider trails will need an entrance permit
- In the event of the rail returning, these side trails would require a rail crossing permit if they cross
- Multimodal is going to recalculate the cost of construction
- Current design goes from Washington Junction to Ayers Junction
- Not going to segregate users but might consider different surfaces where there is room.
- Washington Junction to Comfort -- Ellsworth High School??? in will be rail with Trail
- Scheduling plan is to take the tracks up in one effort, then build as funds allow. Washington County representatives want some of the early construction to be in Washington County.
- still waiting for decision on ATV exception FHWA is very busy now with reauthorization. It has been hard to get their attention.
 - The exemption might allow for funds to be used
 - Need to measure the impacts of ATVs on other users
 - John Ashmore objects to using funds that might result in eventual refusal of ATVs on
